


F Installation




Clean the windshield and paste the electrostatic film onto it.
Avoid introducing air bubble.
DO NOT paste the film repeatedly.



Paste the device onto the electrostatic film and route cable to the disaster box for power supply.



Connect the charger as the figure above.



Adjust the angle to the target direction.

G Mobile Phone Connection

- 1 Scan the QR code to download and install HikDashcam app.



- 2 Add the dashcam to the app.
 - a. Run the HikDashcam app.
 - b. Tap **Wi-Fi Connection**.
 - c. In Wi-Fi list, select the Wi-Fi SSID of the target dashcam and enter Wi-Fi password to build connection.

i • You can set the parameters of the dashcam.
• For iOS, you need to go to Wi-Fi settings of your phone to connect to the Wi-Fi of dashcam.

i Dashcam Wi-Fi default parameters:

- Wi-Fi SSID: HIKVISION-C8PRO-XXXX
(XXXX refers to the last four characters of verification code.)
- Wi-Fi password: 1234567890
(please edit password after logging in for the first time.)

- 3 Edit the dashcam password to activate it to avoid abnormal recording after connecting to Wi-Fi.

H Basic Description

Start Up

Connect the power cord to the car battery.

Device starts recording automatically once the car started.

i When the car is off, device turns into parked monitoring mode and start to record once the current scene changed or collision happened.

Recording

Recordings are divided to ordinary video and emergency video.

You can set the video voice on/off via System Settings or Hikdashcam APP.

When recording with 60 fps, the device will actively shut down adas and rear camera.

I Troubleshooting

Trouble	Solution
The dashcam drops easily.	<ul style="list-style-type: none">• Clean the windshield before installation.• Check whether the 3M tape is tightly stucked to the electrostatic film before the installation.
Starting the dashcam failed.	<ul style="list-style-type: none">• Check whether the vehicle is started and power supply is normal.• Check whether the car charger is tightly connected.• Restore to defaults: hold the RESET button until the startup music is heard.
The dashcam powers off easily.	<ul style="list-style-type: none">• Make sure the power cord is in good condition.• Make sure the power cord is tightly connected to the according interfaces.
Recording is abnormal and indicator is unlit.	<ul style="list-style-type: none">• Make sure that the dashcam started up successfully.• Check whether the TF card is inserted.• Check the status of TF card, e.g. its format, its lifespan.• Change TF card if it is not well.
Recording is blurred.	<ul style="list-style-type: none">• Make sure the protective film is peeled off.• Check whether the windshield or the lens of dashcam is blurred.
Recording is mute.	<ul style="list-style-type: none">• Set audio settings on the device or turn on sound recording in HikDashcam app.• Turn on sound through the the audio control function of the dashcam.
Dashcam reboots itself.	<ul style="list-style-type: none">• Check whether the car charger is tightly connected.• Check whether the car charger is equipped with power supply interface of 5 VDC, \geq 2 A.
Mobile phone cannot connect to dashcam.	<ul style="list-style-type: none">• Make sure HikDashcam app is installed.• Please restart the dashcam to the app.

I Troubleshooting

Trouble	Solution
The mobile phone cannot display recordings.	<ul style="list-style-type: none">It may be relevant with the player or system of the phone. Please connect TF card to your computer and display the recordings.
TF card is not detected when you connect dashcam to computer with the supplied power cord.	<ul style="list-style-type: none">Dashcam does not support data transmission and the supplied power cord is only for charging.If you need to transfer data, please connect TF card to your computer.
Wi-Fi connection takes a long time.	<ul style="list-style-type: none">It may be caused by the interference of the surrounding Wi-Fi signals. Please use the dashcam in an environment of less interference.Shut down unnecessary programs in your phone to release some resources for HikDashcam app and reconnect Wi-Fi.
Dashcam Wi-Fi password is forgotten.	<ul style="list-style-type: none">The default password is 1234567890. If you have revised the password, regain the password by the following steps.
	<ol style="list-style-type: none">1. Hold the RESET button on dashcam until the startup music is heard and the dashcam is restored to defaults.
	<ol style="list-style-type: none">2. Go to Wi-Fi Connection interface in HikDashcam app.
	<ol style="list-style-type: none">3. Select Wi-Fi SSID and log in with default password 1234567890.
No GPS signal.	<ul style="list-style-type: none">Check whether the GPS function is enabled. Normally, the GPS function is enabled by default.
	<ul style="list-style-type: none">Make sure the device is not in the places of weak signal or no signal, such as underground garage.
	<ul style="list-style-type: none">Make sure there is no metal around the device because metal will interfere with GPS signal.Make sure the location where the device is installed is not pasted with radiation protection film. The film will interfere with GPS signal.
